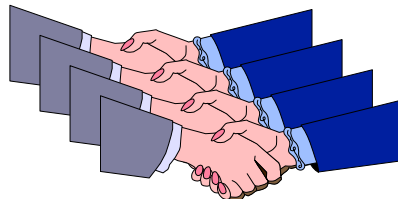
ABOUT US
